Board of Trustees Meeting Minutes

Monday, May 18, 2015

Call to Order:

The meeting was called to order by Mr. Persak at 5:45 pm.

Also, the school will continue to cover spouse health insurance for those spouses that do not have it available at their employer, are unemployed or retired.
